## 3. APPROVE MINUTES OF PREVIOUS MEETING

Minutes of the Parish Council Meeting held on Thursday 7<sup>th</sup> March were approved and signed.

#### 4. CHAIRMAN'S REPORT

Playground Upgrade A draft agreement between TDC and FPC, who will project manage the playground upgrade, has now been provided by TDC and circulated to councillors. The project will be progressed as soon as possible to try to have the works completed for the summer holidays.

Action: Clerk to liaise with FPC's insurers. Clerk and Chairman to progress and report back.

Footpath and Verge on Copthorne Road Cllr. Huntington has reported that the path is inaccessible and a drain appears to be blocked leading to regular flooding and damage to the verge. Cllr. Steeds has asked Surrey Highways to attend.

#### (ii) S137 Funding Request from St. Catherine's Hospice

**Approved:** Councillors agreed to make a donation of £250 to St. Catherine's Hospice which provides support to Felbridge residents. **Action:** Clerk to respond to application and add payment to the Agenda for the next meeting on  $2^{nd}$  May.

(iii) **Approval of costs relating to proposal for migration to .gov.uk website and email addresses** Having previously agreed to migration to .gov.uk, councillors considered four anonymous options for providers. From these options, a decision was taken to appoint a smaller company who offered flexibility and the lowest ongoing costs and were recommended by other smaller councils. **Action:** Clerk to progress and report back.

#### 6. VILLAGE MAINTENANCE

(i) **Grass Cutting**: The Clerk met with Surrey Highways regarding grass cutting for 2024. There is no option for works to be devolved to FPC as was the case for the previous four years. Highways advise that they have new systems in place using GPS to ensure that works are completed and there will be a dedicated website with an interactive map available for works to be monitored and any issues reported. **Action**: Clerk and councillors to monitor.

#### 7. <u>COUNTY COUNCILLOR REPORT</u>

Cllr. Steeds continues to attend regular meetings with Surrey Highways and FPC Planning Chairman Cllr. Clarke regarding the proposed MSDC developments on the Felbridge border and the resulting impact on roads and traffic in Felbridge.

As a member of the SCC Gatwick Sub Committee, Cllr. Steeds has emphasised that in addition to issues with noise and pollution, increased traffic would have a particularly adverse impact on Felbridge roads and the Star Junction in particular.

Following Cllr. Huntington's report of a blocked drain on the pavement on Copthorne Road, Cllr. Steeds has visited the site with a Highways officer and arranged for the drain to be cleared and added to the Highways schedule for regular clearance.

Cllr. Steeds had been informed that boxes of magazines were being stolen outside newspaper retailers in both Felbridge and Dormansland and was contacted by the Federation of Small Retailers about the problem. The thefts were affecting sales. She reported this to Surrey Police and fortunately the thief was apprehended at about the same time as her report.

### 8. DISTRICT COUNCILLOR REPORT

Cllr. Moore reported that a cyclist had come off their bike after hitting a pothole at the Star Junction The latest air quality results were now available from TDC and Cllr. Moore would send them to the Clerk. Cllr. Clarke explained how the figures were generated and how the results could be interpreted.

### 9. COUNCILLORS' REPORTS/UPDATES

**Tree debris on Grass Verge/Village Green**: Cllr. Hall reported that there were tree branches and debris on the grass verge on Crawley Down Road and on the Village Green. <u>Action</u>: Clerk to report to TDC as both areas are Common Land.

**Limes Pond**: Cllr. McBryde asked for an update on when the Limes Pond would be cleared and the fence repaired. The Clerk responded that she chased this regularly with TDC and believed the delay to be due to pond clearance now being undertaken by volunteers.

**Gatwick Visit:** Cllr. Groom had attended a behind the scenes visit to Gatwick for councillors. The visit was useful and updated information had been provided on future plans and noise and pollution reports. Traffic at the airport is now back to 84% of 2019 levels. A new fast charger point for electric vehicles is also now available for public use at Schlumberger House near the entrance to the South Terminal.

#### 10. SURREY HIGHWAYS/RIGHTS OF WAY/TDC

**Potholes on the A264:** Patching in this area appears to be taking place on a weekly basis.

(iii) MSDC Development on Felbridge Border

Meeting with Surrey Highways, Cllr. Steeds and Cllr. Clarke

This useful meeting followed FPC's email to Highways following the concise 'no objection' consultation response from an officer to the Imberhorne Farm development which Cllr. Clarke had noted on the MSDC Planning Portal.

The officers attending were asked if they were satisfied that this development would mitigate its highway impacts, as this is the test the Inspector gave to MSDC for them to determine the application. In a positive response, SCC confirmed they are not satisfied and are having continued discussions with MSDC and TDC. SCC feel that TDC should be consulted on this application due to the significant impacts that it could have upon the roads within Tandridge. SCC are planning to send further comments to MSDC in the next couple of weeks to clarify the position and a follow up meeting is planned. SCC are pushing that if this development goes ahead that their main aim is to secure physical improvements in the area and not financial contributions to schemes (such as the 'corridor project') which may never be implemented. It was noted that Surrey Highways are being helpful and proactive in working with both FPC and TDC in response to the additional proposed MSDC developments in the Felbridge area. Cllr. Clarke explained that while procedural restrictions mean that Surrey Highways are unable to formally object to these applications, they are working to ensure that conditions relating to Highways are imposed and mitigation delivered.

#### 12. CLERK'S REPORT

**Antler Homes Development** A resident has reported that at least one home is occupied and provided a photograph. This has been reported to MSDC since there is a condition which prohibits occupation before all Highways works are completed.

#### King's Portrait

Delivery of free portrait being provided for all Town and Parish councils is expected within the next week **Temporary Toilet Hire for 2024** 

The supplier has confirmed that costs would be held at the same level as 2023. To be added to the Agenda for the May meeting.

#### **Policies Review**

Councillors were asked to review the policies on the FPC website in advance of the Annual Meeting to be held immediately prior to the May meeting. The Clerk is reviewing the CCTV policy using data from the ICO website and will upload once available.

#### **SGN** Emergency Gas Works

Works to identify and repair a gas leak at the junction with the Copthorne and Crawley Down Roads started on Wednesday.

#### **SGN** Equipment Upgrade Works

Works will start at the end of April to upgrade the gas network on the A22 between the Mormon Temple and Woodcock Hill. Temporary lights will move along the A22 as works progress. It is expected to take 12 weeks.
