(iii) **Approval of Regular Payments by Standing Order/Direct Debit (Payroll) 2026-27: Approved:**

(i) **Highways Grass Verge Cutting:** Second cut scheduled for completion by end April.

## 7. COUNTY/DISTRICT COUNCILLOR REPORT

**Unitary Authority Preparations:** As a member of the group working on the process to transfer duties and powers from Surrey CC and Tandridge DC to the East Surrey Unitary Authority, Cllr. Steeds is currently working with colleagues to compile a risk register and to set up a programme for splitting larger contracts between the two new councils. Further discussions are taking place on how to manage planning departments.

**Vehicle Activated Sign, Copthorne Road:** At Cllr. Steeds request, SCC have added a replacement VAS for the Copthorne Road to the list to be actioned in either 2026 or 2027. The latter would need to be approved by the new East Surrey Council.

**Dormer Cottage Site:** Cllr. Steeds to contact TDC Planning Enforcement regarding the ongoing issues including mobile homes being used for accommodation; plant and equipment being stored; storage containers being moved to site and bright security lights being installed along the length of the side fence. These actions are all in breach of planning.

## **9. COUNCILLORS' REPORTS/UPDATES**

**Copthorne Road Footpath:** Cllr. Huntington reported that the section of footpath from Toads Croak to Houseman Way is still being impacted by overgrowing vegetation and the grass verges are encroaching on the now narrow footpath. **Action:** Cllr. Steeds to raise with the TDC Street Cleaning team.

**Haskins Roundabout:** Cllr. Clarke noted that Highways have been unable to complete a full grass cut due to the damage caused by vehicles being deliberately driven over the roundabout.

**A22 at Star Junction:** Cllr. Groom reported that there was a lot of debris on this section of road which was causing a hazard for cyclists. **Action:** Cllr. Steeds to raise with TDC.

**(iii) Planning Enforcement: 2025/781 Dormer Cottage, Woodcock Hill, Felbridge, Surrey, RH19 2RD**

Planning Officer responded to update request to say that the developer had emailed some drawings relating to the new application and has been asked to upload them to the planning system. At 2 April that had not been done. The site continues to be used and occupied in breach of existing planning permissions.

**(iv) MSDC Development on Felbridge Border** While road cleaning continues to be a problem, fewer HGVs appear to be using Rowplatt Lane and deliveries are being better managed with timings now mostly avoiding school hours and no waiting on the road.

**Signs on Village Green:** Site Manager asked for removal of signs lying face down to allow grass to be cut.
