(ii) Request for S137 Funding: St. Catherine's Hospice submitted a funding request to help with the cost of supporting outreach workers including those who cover the Felbridge area.

## 7. <u>COUNTY COUNCILLOR REPORT</u>

Cllr. Steeds has asked the Transport Development Planning Team at Surrey Highways for a meeting following the withdrawal of the initial application by Barratt Homes for 61 dwellings and the new application for the full 200 dwellings due to the clear impact this would have on the Star Junction and will follow up. When last asked for a meeting, Highways confirmed that TDC had failed to consult them on this application despite being required to do so and they had asked TDC to act on this statutory consultation.

Cllr. Steeds attended a meeting convened by Infrastructure First along with Planning Chairman Jeremy Clarke and other interested parties regarding the Barratt Homes application on site SA19.

## 8. <u>DISTRICT COUNCILLOR REPORT</u>

Cllr. Moore has raised concerns with Surrey Highways regarding the difficulty of exiting two driveways on to the A22. Another resident had voiced concerns about accessing the A264 from their driveway. Two residents had contacted Cllr. Moore regarding the resurfacing works on the Copthorne Road. Cllr. Moore is encouraging residents to comment on the latest Barratt Homes application. A TDC boundary review recommends that Felbridge be joined with Dormansland and Felcourt to create a three ward group.

Cllr. Moore was asked to raise the following matters at TDC:

- 1. Why were the validation dates for the Barratt Homes applications amended to show validation on the date of receipt when this didn't actually occur until four weeks later
- 2. To raise a question regarding TDC's engagement with Surrey Highways as a statutory consultee on the Barratt Homes application.
- 3. Regarding the Boundary Commission proposed changes in the Tandridge District to question why Woldingham ward is shown as remaining as a single ward, alongside a neighbouring a two ward group, when Felbridge was not offered this option.

**Action:** Cllr. Moore to research and report back.

#### 9. COUNCILLORS' REPORTS/UPDATES

**Skips at Beaver Farm:** Planning enforcement have visited this site and advised that a planning application must be submitted.

**Box Junction on A264/Crawley Down Road**: The box was repainted following the resurfacing. Cllr. King suggested that Surrey Police could be asked to monitor use as many drivers continue to drive into the box without a clear exit. **Action**: Clerk to report. **Infrastructure First Meeting:** Cllr. Clarke attended a meeting along with Cllr. Steeds and other local councillors. The affect of the proposed SA19 development on transport is a major concern and is the main focus of the IF response to this development.

11A Crawley Down Road Construction Management Plan: Cllr. Clarke noted that TDC have still not approved a CMP for this development despite it being a requirement of planning for approval before any works commenced. Works started on this development in January and there have been repeated issues with parking obstruction. Welbeck Homes Meeting Cllr. Clarke has been invited to join a meeting with the developers of the SA20 site at Imberhorne Lane for an update and will report back. Demolition of 71 Crawley Down Road: It was noted that works by SGN were taking

**Demolition of 71 Crawley Down Road**: It was noted that works by SGN were taking place from 30<sup>th</sup> May under two way lights to remove the gas supply to this property in advance of the Barratt Homes demolition application being approved thus rendering it unsuitable for rental. **Action**: Clerk to advise MSDC Planning.

#### 10. SURREY HIGHWAYS/RIGHTS OF WAY/TDC:

**Openreach Works on Copthorne Road.** Contractor was required to return and remove two way lights which had been left in place unnecessarily and were creating long delays.

## (i) Applications in Felbridge

# 2022/1315 Ebor Lodge, London Road, Felbridge, Surrey, RH19 2QS

**Resolved:** Felbridge Parish Council have no objection to the intensification of this site and are pleased to see the garage has been dropped to a single storey and support that as being a viable way forward. Despite dropping the height of the rendered wall from 3m to 2.4m, we are still concerned about the potential reflective noise and the potential for that to have a negative impact on the opposite neighbours. It is suggested that an independent noise assessment should be made to support the application before it is approved.

#### 12. CLERK'S REPORT

**Temporary Toilet**: Now in position on the patio area at the back of the Village Hall **S106 SA19/Barratt Homes Application** Clerk has again chased up MSDC officer and asked for a revision of the play and leisure funding provision since the full development has now been brought forward. The existing funding requirement was based on 61 dwellings.

## **Bus Service Improvement 291 – from Metrobus**

The 291 will be improved to run hourly in each direction through the evening from Crawley, Three Bridges and East Grinstead. There will also be later journeys to and from Tunbridge Wells and Crawley. The last bus from Crawley being at 2322 and from Three Bridges at 2327. There will be a much later journey from East Grinstead at 0019

#### **TDC Survey on Council Services**

Information on this survey has been added to the Felbridge Parish Council website.

**Verge Crawley Down Road/Rowplatt Lane**: Report from resident that a patch of grass seems to be permanently water logged.

**Felbridge School**: Email from school regarding damage to fence between the skateboard ramp and school grounds. Referred to Cllr. Moore to raise with TDC.

#### Road Closure near Wheelers Way

Information from Worth Parish Council. Road closure on Felbridge Road between Wheelers Way and Furnace Wood from 19-23 June for SGN to bring gas supply to development.
