4. <u>CHAIRMAN'S REPORT</u>

Playground Upgrade The project is on hold while TDC prepare the necessary legal agreements relating to funding. Once this has been addressed, an order can be placed. **Action:** Clerk and Chairman to monitor and report back.

Footpath and Verge on Copthorne Road Cllr. Huntington has reported that the path is inaccessible and a drain appears to be blocked leading to regular flooding and damage to the verge. **A264 Potholes near Furnace Wood** Reported again and noted that the Surrey Highways map showed that multiple reports have already been made relating to the road surface at this location.

(iii) **Internal Audit:** Date has been set in May for the internal audit which will enable the AGAR to be signed off at the June meeting and documentation to be prepared for the external audit.

6. <u>VILLAGE MAINTENANCE</u>

(i) **Grass Cutting**: Surrey Highways have confirmed that they will retain responsibility for grass verge cuts. Meeting arranged between Clerk and Highways to discuss options for Felbridge. <u>Agreed</u>: While acknowledging that for 2024-25 it will be necessary for Felbridge verges to be cut by the Highways contractor, councillors would prefer that another contract is agreed which would allow FPC to manage Felbridge grass cutting as has been the case for the past four years. <u>Action</u>: Clerk to report back.

7. <u>COUNTY COUNCILLOR REPORT</u>

Cllr. Steeds has helped set up a meeting between the Clerk and Surrey Highways to look at options for grass cutting in Felbridge following the end of the current contract between SCC and FPC.

She continues to liaise with FPC, SCC and TDC regarding the Highways implications associated with the proposed Barratt Homes development off Crawley Down Road and attends regular meetings

Cllr. Steeds has chased the Community Gang resource to carry out works on pavements, hedges, etc as previously agreed.

Continues to liaise with Surrey Highways regarding the potholes on the A264 by Furnace Wood requesting full resurfacing instead of repeated repairs.

Cllr. Steeds is on the Surrey County Council sub-committee looking at the effect of Gatwick expansion on smaller villages, particularly relating to traffic, and has highlighted the issues specific to Felbridge.

9. <u>COUNCILLORS' REPORTS/UPDATES</u>

Planning Enforcement: Cllr. Clarke reported that MSDC provided Parish Councils with a list of outstanding enforcement matters and suggested that TDC could be asked to provide the same information. **Action:** Clerk to submit a request.

Coronation Planter: Cllr. Huntingdon has cleared the planter and will add more compost before further planting.

10. SURREY HIGHWAYS/RIGHTS OF WAY/TDC

Surrey Highways

Potholes on the A264: Works were taking place on 7th March which appeared to be temporary filling rather than the resurfacing which is needed in the area between Doves Barn and Furnace Wood area. TDC

Limes Pond Clearance: Clerk has again chased up this outstanding work.

11. <u>PLANNING</u>

(i) Applications in Felbridge

2024/121 Rustings, Domewood, Copthorne, RH10 3HD

Resolved: No Action

2024/103 The Barn, Pixewood, Rowplatt Lane, Felbridge RH19 2PA

Resolved: Felbridge Parish Council object to this application for a new detached structure within the Green Belt within what was Pixiewood Farm. Pixiewood Farm was developed with a built volume far greater than the pre-existing volume and as a result permitted development rights were removed to avoid a proliferation of additional structures that would be detrimental to the openness of the Green Belt. We therefore see that this proposal would have a negative affect on the Green Belt. It is noted that there are no volume calculations provided so it is impossible to evaluate how this proposal would equate to the Green Belt policy.

(iii) MSDC Development on Felbridge Border

Proposed Barratt Homes Development off Crawley Down Road - TDC Meeting

Cllr. Clarke met with a senior planning officer from TDC to discuss the impact of the development on Felbridge residents. Cllr. Clarke went through the data going back to 2015 showing that the Star Junction was operating well above capacity at that time and that 1240 dwellings have been completed in East Grinstead since that study with no Highways improvements delivered. While the current corridor project is looking at this junction, the timeline for its report is after this proposed development will be occupied. It was noted that SCC are only able to consider if there is a severe impact on the Star Junction and that this test is very difficult to prove. However, TDC Legal advice to the Planning Policy Committee on 16th November 2023 stated that all applications around the A264/A22 corridor MUST mitigate their traffic impacts until such time as the Corridor Study has completed and it is known whether a solution exists and will be funded. This need to mitigate the transport impact also echoes the DPD Inspector's statements about mitigation needs to be considered in detail at the Planning Stage rather than being resolved as part of the Site Allocation. Surrey Highways have confirmed in their formal response that the application has not mitigated its traffic impacts. It was also noted that Surrey Highways have said that as the Gullege Bridleway is unlit and regularly floods, it would not meet their requirements for a sustainable transport route. The officer confirmed that as a significant development this application will be considered by the TDC Planning Committee. This would be in April at the earliest.

(iv) **24 Rowplatt Lane Development**: A Construction Management Plan has now been submitted by the new developer suggesting that works will soon commence.

The option of creating a flyer to raise awareness of the meeting, the current Parish Councillor vacancy and to share local information was discussed. **Action:** Clerk to add to the agenda for the Planning Meeting on 21st March for approval.
